PROFESSOR (Pay Scale Rs. 1,44,200-2,18,200)

Qualifications and Guidelines:

1. A Bachelor's degree in Veterinary Science/Veterinary Science and Animal Husbandry/Dairy Science/Fisheries Science in the concerned discipline from SAU/ SVU/Deemed University or any other recognized university.
2. A Master's degree with at least 55% marks (50% for SC/ST) or an equivalent grade in a point-scale, wherever the grading system is followed in concerned/allied subject from SAU/SVU/Deemed University or any other recognized university.
3. An eminent scholar having a Ph. D degree in the concerned / Allied Subject as notified by the university, and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 research publications in the NAAS rated / UGC listed journals.
4. A minimum of 10 years of Teaching / Research / Extension experience in University/ College as Assistant Professor/Associate Professor and / or research experience at equivalent level at the

University/ National Level Institutions with evidence of having successfully guided doctoral candidate/Master degree candidate, out of which **two years of service / experience in the cadre of Associate Professor** in the pay band Rs. **1,31,400-2,17,100** as applicable to Associate Professor or equivalent positions of ICAR/UGC shall be mandatory.

5. Knowledge of Kannada is Mandatory:

Note: If candidate did not study Kannada as a first or second or third language in S.S.L.C or its equivalent qualification, then the candidate shall be eligible for interview in respect of Professor post only if He/She qualifies in a test in Kannada language. This test shall comprise of one paper carrying a maximum of 150 marks. For qualifying in this paper, a candidate must secure a minimum of 50% marks. The standard of this paper shall be that of first language Kannada at S.S.L.C level.

2. A Master's degree with at least 55% marks(50% marks for SC/ST) or an equivalent grade in a point-scale, wherever the grading system is followed in concerned /allied subject from SAU/SVU/Deemed University or any other recognized university.
3. A good academic record, with a Ph. D degree in the concerned/Allied Subject as notified by the university.
4. A minimum of eight years of teaching experience and / or research and / or extension in an academic / research position equivalent to that of Assistant Professor in a University, College, or Accredited Research Institution in a pay band Rs.57,700–1,82,400 as applicable to Assistant Professor or equivalent cadres of ICAR/ UGC with a minimum of **Seven publications** in NAAS rated / UGC listed Journals.
5. Knowledge of Kannada is mandatory

Note: If candidate did not study Kannada as a first or second or third language in S.S.L.C or its equivalent qualification, then the candidate shall be eligible for interview in respect of Associate Professor Post only if He/She qualifies in a test in Kannada language. This test shall comprise of one paper carrying a maximum of 150 marks. For qualifying in this paper, a candidate must secure a minimum of 50% marks. The standard of this paper shall be that of first language Kannada at S.S.L.C level.

6. A minimum score as stipulated in the prescribed score card.

ASSISTANT PROFESSOR (Pay Scale Rs. 57,700 – 1,82,400)

Qualifications and Guidelines:

1. A Bachelor's degree in Veterinary Science/Veterinary Science and Animal Husbandry/ Dairy Science/Fisheries Science of respective discipline from SAU/ SVU/ Deemed University or any other recognized university.
2. A Master's degree with a minimum of 55% marks (50% marks for SC/ST) (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/Allied subject as notified by the university from SAU/SVU/Deemed University or any other recognized University, or an equivalent degree from an accredited foreign University.
3. The candidate must have cleared **NET in concerned subject** conducted by the UGC/ICAR/CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D Degree in

accordance with the **University Grants Commission** (Minimum Standards and Procedure for award of M. Phil./Ph.D. Degree) **Regulations, 2009 or 2016** and their amendments from time to time as the case may be exempted from NET/SLET/SET.

Note: MSVE 2016 Regulations Section 14.1 reads “The persons with only basic Veterinary qualification, included in Schedules to the Act, registered with a State Veterinary Council and having a Post-graduate Degree in the concerned subject, shall be recruited as teaching faculty in the Veterinary Colleges and preference shall be given to the candidates who have qualified National Eligibility Test conducted by Agricultural Scientist Recruitment Board. Accordingly, the Candidates shall be considered for selection only if he qualifies NET exam in the Concerned Subject Conducted by Agriculture Scientist Recruitment Board.

4. NET is exempted for such Master's degree programmers where NET is not conducted by ICAR/UGC/CSIR/SLET/SET in the concerned/Allied subjects as notified by the university.
5. NET is also exempted for those who obtained Ph. D degree from a foreign University / Institution with a ranking among top 500 in the world University Ranking. However, such candidate has to fulfill the conditions as per the Government Order No.AHF113 VET 2018/Bangalore dated 16.3.2019.
6. Those candidates who have registered for the Ph. D, Program prior to July 11th 2009, shall be governed by the provisions of the then existing regulations of the institution awarding the degree and such Ph. D candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions.
 - a) The Ph. D degree of the candidate has been awarded in a regular mode.
 - b) The Ph. D thesis has been evaluated by atleast two external examiners.
 - c) The Ph. D viva voce of the candidate has been conducted
 - d) The candidate has published **two research papers** from his/her Ph.D work, out of which at least one is in a referred journal.
 - e) The candidate has presented at least **two papers** based on his/her Ph.D work in conferences/seminars sponsored by the UGC/ICAR/ICSSR/CSIR or any other similar agency.

Note: The fulfillment of these conditions is to be certified by the **Registrar** or the **Dean** of University concerned is **mandatory** otherwise candidates will not be eligible for NET exemption.

7. Knowledge of Kannada is mandatory:

Note: If candidate did not study Kannada as a first or second or third language in S.S.L.C or its equivalent qualification, then the candidate shall be eligible for interview in respect of Assistant Professor Post only if He/She qualifies in a test in Kannada language. This test shall comprise of one paper carrying a maximum of 150 marks. For qualifying in this paper, a candidate must secure a minimum of 50% marks. The standard of this paper shall be that of first language Kannada at S.S.L.C level. Those candidates who have already passed Kannada Departmental Examination shall compulsorily attach signed copy of Certificate by KPSC authority.

8. Age Limit (Only for Assistant Professors): The candidates should have not crossed 40 years of age in case of **General merit, 43 years** of age in case of **2A, 2B, 3A, 3B** and **45 years** in case of **SC, ST and Cat-I** category candidates as on the last date of submission of application. Age relaxation for in-services candidates and other categories shall be considered based on the relevant orders of Government of Karnataka in vogue.

1. The Short listing of the candidates shall be governed based on Prescribed Qualification, Score card and guidelines for Direct recruitment of teachers (No:R/KVAFSU/ACM-CA/Teaching scd/2025-26 dated:12.11.2025 (KVAFSU-Prescribed Qualifications, Score card and Guidelines for Direct Recruitment of Teachers)) and score card As prescribed under Annexure-1-3 as per guidelines of KVAFSU available on KVAFSU website.
2. Online mode of submission of applications shall be essential.
3. Candidates are advised to satisfy themselves before applying that they possess at least the minimum essential qualifications laid down in the advertisement.
4. Applicants shall first register on the Recruitment portal on the KVAFSU website, after which, they can fill up the prescribed online application form.
5. Separate applications shall be submitted for different positions.
6. Before starting to fill up the form, please ensure that you have the following, a scanned copy of photograph, signature, caste/tribe/community certificate (if any), educational qualifications, experience related documents and all other required document specified the respective score card in JPEG/JPG/PDF format. The photograph/other document should not exceed 500 kb each. Candidates are advised to ensure that all their documents are readable and clearly visible before uploading. Uploading Thumbnails/invisible document will lead to rejection of application.
7. While filling the online application, if the browser closes unexpectedly or if the candidate is logged out, they may use the login information sent to his/her email to login again. Candidates should wait until the application is properly submitted and payment is made and should not close their browser abruptly before the process is complete.

15. Shortlisted Candidates must Submit self-attested copies of certificates, mark-sheet from matriculation (10th Standard) onwards in support of the qualifications, reprints of publications and certificates in support of their research score claimed for the post along **with the 3 sets hard copies of the application form during the physical verification of original Documents.**
16. Mere eligibility will not entitle any candidate for being called for interview. Applicants having higher qualification and merit will be given preference. **Good Academic Record** for all teaching positions shall be as defined in the KVAFSU Score Card.
17. Candidates belonging to SC(A),SC(B),SC(C)/ST/Cat-I/2A/2B/3A/3B category should submit proper caste/tribe/community certificate as per the proforma prescribed by Government of Karnataka duly issued by concerned competent authority.
18. In service candidates who claim reservation under **2A, 2B, 3A, 3B**, should compulsorily attach the caste certificate and their claim should be as per Govt. Order No. **DPAR 21 SBC 85, Bangalore dated 19th September 1985**
19. Candidates belonging to 371(J) category should submit certificate as per the proforma prescribed by Government of Karnataka vide Order no DPAR 43 HKC 2013 dated:29.01.2014 issued by Assistant Commissioner only.
20. **Local candidates of the Kalyana-Karnataka region** are eligible to apply for positions in both the **Local Cadre** and the **Residual Cadre**. 21. It is hereby clarified that if a local candidate from the Kalyana-Karnataka region opts for and is appointed to a position in the **Residual Cadre**, such candidates shall **not be eligible** to claim reservation benefits under **Article 371(J)** during their entire period of service, as per the prevailing rules. 22. Those who claim reservation **Rural quota** (Form-1 & 2) should compulsorily enclose certificate issued by the competent authority in the prescribed format only.
23. Non-Creamy Layer certificate issued by competent authority is mandatory for claiming Rural Quota under GM and 2A, 2B, 3A, 3B Categories.
24. Any corrigendum/ changes/ updates related to the recruitment process shall be available on official website of the University www.kvafsu.edu.in only.
25. The application without payment of prescribed fees and Incomplete application form will be rejected.
26. Separate application along with registration fee must be submitted for each of the Post applied.
27. For all the information furnished / claims made, sufficient and appropriate evidence from competent authority should be enclosed.
28. Physically challenged persons should furnish the Medical Certificate from District Medical Board / appropriate authority along with the application.

29. Candidates of Veterinary Science should possess and upload (both side if the expiry date in mentioned on back side) a valid registration of Karnataka Veterinary Council/Veterinary Council of India. Signature and the Expiry date must be clearly visible, incomplete/poor visibility of any sought the application will be rejected.
30. Educational qualifications for the period of studies should be indicated clearly with date, month, and year of joining and leaving studies along with conversion certificate if applicable.
31. Employment record details of service rendered by the applicant in different cadres clearly mentioning date, month and year of appointment, scale of pay and pay drawn.
32. Inservice Candidates claiming age relaxation must compulsorily submit the in-service certificate form from their respective controlling officers (Competent Authority) failing which their applications shall be summarily rejected.
33. The period of study during the service should be indicated duly certified from their respective controlling officers(Competent Authority).
34. Service rendered outside KVAFSU if any, should be clearly indicated with proof from their respective controlling officers (Competent Authority).
35. Relaxations and concessions for SC(A),SC(B),SC(C)/ST/Cat-I/2A/2B/3A/3B/PH/T will be applicable in accordance with reservation policy of the GOK and subsequent clarification/directives issued from time to time to this effect.
36. In Case of non availability of candidates in Concerned PH Category persons with other PH category would be considered for selection i.e if VH eligible candidate is not available the post shall be filled with OH/HH eligible candidates.
37. Procedure for the Provisional Selection List Preparation of the candidates shall be in accordance with the Karnataka act no 1 of 2019
38. If a candidate having selected in previous KVAFSU teaching recruitments but did not join the selected post and if he further applies to this notification and fails to join he would be made ineligible for all future recruitments of KVAFSU.
39. The eligibility of an applicant shall be determined in accordance with the KVAFSU Acts, Statutes and approved Scored cards and its subsequent amendments and/or in accordance with the relevant regulations of concerned Regulatory bodies.
40. The University shall verify the antecedents or documents submitted by a candidate at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedent/ background and has suppressed the said information, then his/her services shall be terminated.
41. The University reserves the right to withdraw any advertised post(s) at any time without giving any reason.
42. Selected candidates will be entitled for new pension scheme as per Govt. order No. FD (SN) 04 PET 2006 Dated 31.03.2006 and as amended from time to time.
43. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the University reserves right to modify/withdraw/cancel the appointment without any communication made to the candidate. However, under the extraordinary circumstances, the above conditions may be relaxed.
44. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
45. Selection of in-service Applicants shall be subject to the fulfillment of Government order DPAR 19 SRR 2020 dated 12-10-2020.
46. Canvassing in any form will be liable to disqualification.
47. No interim correspondence shall be entertained.

48. Incomplete applications are liable to be rejected and the University is not responsible for any kind of delay in submission.
49. **The eligibility of the candidate will be determined as per the Last date of submission of application i. e 20.06.2026.**
